C I R C U L A R

Consequent upon the decision taken in the meeting held in the chamber of the Minister-of-State , Sundarban Affairs Dept. in presence of the Principal Secretary, Sundarban Affairs Dept. on 11.07.2011 and on the basis of the subsequent scrutiny of the documents and test certificates of renowned testing authorities of the country submitted by M/s SRMB SRIJAN LTD. a renowned TMT Bar manufacturer in India, in support of introduction of a permanent anti-corrosive treatment over steel reinforcement bars and structurals to protect the steel materials from corrosion due to high degree of salinity in the tidal river region of Sundarban Area , it has been decided that Sundarban Development Board may not have any objection to apply such anti-corrosive treatment and include the item of providing coating of ZINGA film on TMT bars and exposed metallic structure or procurement of "SRMB AZAR" a corrosion proof Zinga coated reinforcement bars as per Belgium based anti-corrosive treatment technology in the bill of quantities/schedule of the forth coming projects of Bridge, culvert, Jetties, sluice gates, buildings etc. under Sundarban Development Board to increase the life span of the R.C.C. structures constructed in saline zone of Sundarban region upto a considerable periods of time.
